B. REVISE Details 3 and 4 to include on the outside sideslopes at least 12 INCHES General
Fill with the upper 6 INCHES to be Topsoil.

GENERAL FILL SHALL INCLUDE TOPSOIL FOR THE UPPER 6 INCHES. SEED
